

**Miss Rubber World 2012 Contest**  
**Event Guidelines, Rules and Entry Form**

The contest will consist of three parts requiring at least 2 different outfits that are AT LEAST 50% rubber/latex, with PVC/Neoprene/spandex/vinyl being accepted for the rest if necessary, but NO LEATHER! Up to 10 contestants will be allowed, so it is first come first served! Please send in your contestant form before March 10<sup>th</sup>, 2012. Walk-ins will be accepted if we do not have all ten slots filled, but again it is on a first come-first served basis.

Part One is the introduction and pose-off. All the contestants will be on stage at once and be introduced to the judges and the audience. After the last contestant is introduced the contestants will exit and prepare for Part Two.

Part Two will be the On-Stage Interview, consisting of a 3-4 question Q&A with the Emcee. The questions will be *non-political* and related to them explaining their interest in Rubber and promote why they should be the winner. Once the interviews are done there will be a 20-30 minute break to change and get ready for your fantasy sequence.

Part Three will be the fantasy skits. Each contestant must act out a 5-minute rubber fantasy on stage featuring a different outfit from parts 1 and 2. You can do a bondage scene, encasement/dressing/transformation scenario, something humorous, or parody a song, etc. You may bring in whatever props and music you want and can have other performers perform in your skit (except other contestants!). The only restrictions are no live weapons, no exposed genitals and it must be no more than 5 minutes long. The goals are to be imaginative and to *have fun in rubber!* However, it is expected that you put some real thought and energy into it, that it be a genuine expression of your rubber fetish and not just trying to titillate the audience with something cheap and flashy.

Rules: Contestants must be 21 years old or above and proof of ID will be required. All contestants and attendees will be required to sign a photo/model release, but no unauthorized photography or video recording will be allowed. Absolutely no drug use will be tolerated. If you are caught you will be ejected. You must arrive by no later than 9PM to check-in. The date is Saturday March 24<sup>th</sup>, 2012. The location is the Grand Ballroom of the Affinia Manhattan Hotel, 371 7<sup>th</sup> Ave. (7<sup>th</sup> Ave. and 31<sup>s</sup>. St.) NYC. The contest will start at no later than 10PM and is scheduled to finish by 1AM, so please help us stay on schedule! Contestants and judges are to have no interaction prior to the start of the contest. No exposed nipples or genitalia are allowed due to NYC bar laws. It is also noted that all rules and elements of the contest are subject to change without notice!
